RELEASE AND INDEMNITY AGREEMENT

In consideration of Hanlim America Corporation doing business as _____ (“Club”) allowing the Guest named above to have access to and usage of the Club’s facilities to participate in _____ (the “Activity”), I acknowledge, appreciate and agree on behalf of myself, and on behalf of the above named minor, and our heirs, assigns and representatives and immediate family (collectively “Guest”) that:

1. **ASSUMPTION OF RISK:** The risk of personal injury or property damage from participating in the Activity is significant, **INCLUDING THE POTENTIAL FOR PERMANENT PARALYSIS AND DEATH**. Guest is aware and familiar with the the risks and dangers involved in participating in the Activity. Such risks and dangers are accepted whether they are marked or unmarked, hidden, latent or obvious. **GUEST FREELY ASSUMES ANY AND ALL RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE CLUB OR OTHERS, AND ASSUMES FULL RESPONSIBILITY FOR GUEST’S USE OF THE FACILITIES. Parent or Guardian must accompany minors at all times.**

2. **RELEASE FROM LIABILITY AND COVENANT NOT TO SUE:** Guest agrees to **FOREVER DISCHARGE AND RELEASE FROM ANY LEGAL LIABILITY AND TO NOT SUE THE CLUB AND ITS AGENTS, EMPLOYEES, SHAREHOLDERS, DIRECTORS, MEMBERS AND ASSIGNS, INCLUDING BUT NOT LIMITED TO CAMARADERIE CLUB MANAGEMENT, LLC** (“Released Parties”) for any injuries, disability, death, loss or damage to person or property arising out of Guest’s participation in the Activity, **INCLUDING BUT NOT LIMITED TO INCIDENTS ARISING OUT OF CLUB’S OR RELEASED PARTIES’ ALLEGED NEGLIGENCE**, to the fullest extent permitted by law.

3. **INDEMNITY AGREEMENT:** Guest agrees to **INDEMNIFY, DEFEND AND HOLD HARMLESS** Club and Released Parties from any and all losses, allegations, claims, legal actions, proceedings, damages, judgments and liabilities of any kind (“Losses”) that arise out of Guest’s participation in the Activity. I agree to assume liability and responsibility for my and/or my minor’s conduct, including any personal injury or property damage that may result from such conduct, and even though I may choose not be present or participate with said minor in the Activity referenced above.

4. **COMPLIANCE WITH POLICIES:** Guest agrees to follow and abide by all rules, guidelines, instructions and all other policies of any type or kind provided by Club to Guest in relation to the Activity.

5. **MEDICAL CONSENT:** I give permission in the case of injury or similar emergency involving me or my minor for the Club to administer CPR or first aid. In the event that I and/or said minor requires medical attention, I hereby consent to any x-rays, medical treatment or diagnosis or hospital care to be rendered under the supervision of duly licensed physicians, dentists and/or paramedics. I understand that this medical authorization is being given in advance of any specific injury or illness.

6. **PARENTAL CONSENT:** I am the parent/legal guardian of the minor named above and hereby give my permission for said minor to participate in the Activity.

GUEST OR PARENT/GUARDIAN HAS READ, UNDERSTOOD AND AGREED WITH ALL OF THE ABOVE, AND SIGNS THIS CONTRACT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ON BEHALF OF THEMSELVES AND THE MINOR NAMED ABOVE .
